

### The Role: Editor-in-Chief of *RMD Open*

BMJ and EULAR are looking for the next Editor-in-Chief who can continue to shape *RMD Open* into the premier open access journal for rheumatology, maintaining the Journal's high quality standards.

The candidate is an active (or very recently retired) researcher and/or clinical rheumatologist. Specialists in any branch of rheumatology and musculoskeletal disorders are welcome to apply. They will act as an ambassador, upholding the highest ethical standards and editorial policies, as well as actively promoting and developing the journal. Applicants should have an MD and PhD (or similar degree) and should be able to demonstrate their impact in the field. The ideal candidate(s) will have a commitment to education and academic excellence, and editorial experience.

This is an independent contractor position and the term of office is 5 years. The Editor has responsibility for the editorial strategy and content of *RMD Open*, with support from their appointed editorial team and BMJ. Editorial training and technical support will be provided, together with strategic guidance. An annual stipend and other benefits are provided, as well as experienced editorial office support. The Editor should expect to spend approximately 7-10 hours per week in total for journal-related activities, but this will depend on the structure of the editorial team.

To be considered for the role, please send your CV and a covering letter outlining your interest and experience, a SWOT analysis of the journal, and your editorial vision for its future development.
